

THE CLT UNLIMITED PASS — TERMS & CONDITIONS

Valid January 1, 2026 – December 31, 2026

1. Overview

These Terms & Conditions (“Terms”) govern the purchase and use of **The CLT Unlimited Pass** (“Pass”) issued by the Classic Learning Test (“CLT”). By purchasing or using the Pass, the purchaser (“User”) acknowledges and agrees to be bound by these Terms for the 2026 calendar year.

2. Validity Period

The Pass:

- Is valid from **January 1, 2026 through December 31, 2026**.
- May only be used for exams administered during this period.
- Is not eligible for extensions, deferrals, or carryover into future years.
- Expires automatically, along with all unused benefits, on **December 31, 2026**.

3. Covered Exams

The Pass provides eligible registration for:

- CLT
- CLT10

The Pass applies **only** to **Remote-Proctored (RP)** exam administrations.
In-school testing is not included and is expressly excluded from Pass benefits.

4. Non-Transferability

- The Pass is **non-transferable**.
- Registrations may not be reassigned, transferred, sold, gifted, or shared.
- Only the original, verified User may use the Pass to register for exams.

5. Pricing, Discounts & Assistance

- No discounts may be applied to the purchase of the Pass.
- No financial assistance of any kind is available for the Pass.
- “Step Up” or similar external funding programs **do not apply**.
- CLT is not responsible for determining eligibility for any outside financial program.

6. Registration Requirements

- Users must comply with all CLT registration deadlines and procedures.
- Purchasing the Pass does **not** guarantee the issuance of a score; Users must satisfy all testing, identity, and procedural requirements.

7. Refund Policy

- Refunds are permitted until January 31, or until a test is taken, whichever comes first. After that, the Pass is **fully non-refundable**, regardless of usage, availability, or circumstances.
- Prior to that deadline, refund requests may be considered **solely at CLT’s discretion**.

8. Misuse, Violations & Compliance Requirements

Users must comply with all CLT exam policies, procedures, and rules. [Violations of any CLT policy](#)—including but not limited to the following—may result in canceled scores, revoked access, suspension, or a permanent ban:

- Academic dishonesty
- Identity fraud or impersonation
- Sharing, attempting to share, or transferring the Pass
- Violations of remote-testing procedures
- Technology or equipment noncompliance
- Testing-environment violations
- Breach of Code of Conduct guidelines
- Test security violations
- Abusive, disruptive, or prohibited conduct

If a suspension or ban occurs, CLT will revoke the Pass in full and issue **no refund**.

9. Limitations

- CLT is not liable for technology failures, missed registrations, or accommodation decisions.
- Availability of test dates or seating is not guaranteed.
- CLT may update its policies at any time, and Users are responsible for reviewing such updates.

10. Entire Agreement

These Terms constitute the entire agreement between CLT and the User regarding **The CLT Unlimited Pass (2026)** and supersede any prior statements or representations.
